Rep Results

The National Intercentre

Our centre's rep teams found the competition tough at the National Intercentre held in Wellington.

Men

Our Kapiti Coast team played in Section 2 against Hawkes Bay, Wairarapa, Nelson, North Otago and Dunedin. They finished fifth in the section (ahead of only North Otago) which was won by Dunedin with Wairarapa second. **Southland** beat **Auckland** in the final.

Women

Our women's team played against North Harbour, Bay of Plenty, Wairarapa, Central Otago and Southland. They also finished fifth with Bay of Plenty first and North Harbour second. **Nelson** beat **Dunedin** in the final.

Competitions Review

The centre's Tournament Committee recently put out a very wide ranging questionnaire to the clubs. Our club appointed a sub-committee of our selectors plus Grahame Law and Ken Hayward to consider and write our responses to the 30+ questions. On 12 April the clubs met at Otaki to work through the findings. President Jim Bagnall and Ken represented our club. The review was at least partly a response to our club's initiative to seek reform of the Interclub competition which last season was marred by the problem of 'byes'. All of the clubs responded fully to the questionnaire and were represented at a very positive meeting (which lasted 3 ½ hours) and there was considerable consensus on the main issues. There was a perceived need for major changes. Most of the details will be revealed later but some of the main points are:

- Qualifying in centre open events will still be 2 out of 3 to qualify, not in sections of four as we had
 advocated to avoid the need for post section play on Mondays. Instead there will be a Finals days for
 the Centre Open events at the end of the season. There will be C of C days spread over the season
 like in the 2019-20 programmes, which most clubs preferred.
- There will be one spare day scheduled before Xmas and one later in the season.
- The question of byes was discussed in a lot of detail and the TC asked to avoid byes in open events at all costs e.g. fill fields to even numbers by any appropriate measure.
- Penalties for not fulfilling entry commitments it was agreed that a penalty of \$ 150 be applied for failure
 to turn up on a day of Interclub or Pennants. (This will need to be ratified by the AGM.) And, all
 competitions will be played to a conclusion no early finishes on the last day.
- Clubs wanted a system to assess and grade greens the TC to investigate further.

Interclub It is fair to say that our club's ideas for reform of the Interclub competition (in particular) were pretty well received, and in a lot of cases should be implemented for the new season.

It was agreed that Premier I continue as at present as the format of singles, pairs, fours was set by the national competition, but it was also agreed that clubs could enter a second team in that competition with the TC able to set a limit of 10 teams in that division. If there are an uneven number of teams the team that finished in a lower position the previous season would be relegated / not accepted. Premier II would probably also continue in the same format.

Three games would still be played in a day (we lost that one) but there would be a time limit of 2 ¼ per game. Draws would be scattered.

Our LBC proposal that Division III could be an 'any gender' competition was agreed to - with 5 players, a pair and a triple, to enable the smaller clubs to compete. This should lead to more entries and perhaps even another division.

Pennants To encourage greater participation clubs could enter teams of 'four', rather than two fours as at present, in any division with a maximum of 16 teams per division. A single team result would determine the winner. Bonus points and a scattered draw to be retained. The number of ends played to be reviewed.

Bowls3Five Our LBC proposal that each club who wished to enter would run their own internal competition with their winning team to go on to a centre final – like C of C's – was accepted.

Mid Week Events

Clubs want fewer mid week events. As a result events like the Leila Secker, Melva Ritson, Seddon Shield and Horowhenua Cup will not be played. Events for players Under 10 yrs will be retained. This will enable clubs to focus on their own events and help boost participation in weekend events.

A draft programme has now been released and clubs have responded to it. More next issue.

The End of Play at Levin Women's

Sadly the Levin Women's club is closing at the end of the season bringing to an end 79 years of competition on their Bath Street green. The club held its final gala sponsored by I C Mark on 8 April.

The club was formed in February 1942 and the members initially played on a small green in Salisbury Street but a year later the Council made the land on Bath Street available for a nominal annual fee. Although the club was first known as Levin Women's it was changed to Horowhenua Ladies in 1946 because it was known locally as the 'Ladies Green'. To avoid confusion the name reverted to Levin Women's when the Levin Bowling Club opened a Women's Section in the 1970's.

The first clubroom was Thompson House's stone gardener's cottage built in 1905 which remained unlined and with no toilets, ceiling or kitchen until 1963. A western part of the clubrooms and powder room was added in 1975 - not without controversy as it involved removing the Thompson House swimming pool. A further extension was built in 1984.

In the early period the green was only a 'grass green' mowed with an ordinary gardens mower. In the late 1990's the club was threatened with closure because of the expense of maintenance. Eventually it was agreed for the Council to lease the land to the club who undertook to maintain it themselves.

Over recent years falling and ageing membership and the inability to attract new players has made the club less viable. Approaches were made to amalgamate with the Levin RSA club but this did not eventuate. In addition issues with green keeping coupled with reliance on the town water supply and earlier and more stringent water restrictions had become major problems.

In April the club's lease needed to be renewed but the members did not feel they could stay viable for a further three years so the decision was made to close. Long time club President **Carrell Knight** reports that the club is solvent and that they are in negotiations with the Council in relation to their buildings. She stated in a recent letter to clubs that some of their members may go on to join other clubs, though unlike in the case of the Raumati South club, they would not be able to take any financial benefits to their new clubs.
