# Playing Bowls Gets More Complicated

For nearly two years now we have all been dealing with the various issues caused by the Covid-19 pandemic. To date we have dealt with lockdowns and a number of restrictions which have impacted on our ability to play our sport.

There will be new requirements for the club to meet when the 'traffic light' system goes into operation on 3 December. One major new requirement for players is that they must register their vaccination status with the club and that only fully vaccinated members will be able to enter the club premises or take part in bowls events at other clubs (see Page 2).

Recently our greens were assessed by an outside consultant as to their suitability for centre events. While our Cotula green passed the test our Dales green was "not recommended for Centre play due to excessive speed". Surely our green is not too fast during the warm summer months? And what of Waikanae?

Pennants and Interclub are well underway and while our teams may not always be winners it is important that our club is represented at that level of competition.

# A 'Vaccinated Club'

Levin Bowls, along with all clubs in the the centre, is now a 'vaccinated club.' This means that all members and visitors to the club must be vaccinated. This applies to club members, housie players, the art group and, from January, all Business House bowlers.

It also means that players selected in club teams for events at other clubs (e.g. Pennants, Interclub, Rotary, Galas etc) must be able to show either their electronic or printed My Vaccine Pass when they play at other clubs.

Our members need to be registered at our club by Friday 3 November by having their Vaccine Passports recorded on the club records. You can do this on roll up days. If a member is not vaccinated by 3 December and subsequently gets vaccinated they can apply for a special registration.

Anyone having problems getting their My Vaccine Pass can get help at Berry's Pharmacy at the Medical Centre in Liverpool Street. You will need to take your NHI number with you. You can find it on a doctor's prescription, prescription receipt or a letter from a hospital.

# Kapiti Coast v Wairarapa

Held at Paraparaumu Beach on Sunday 28 November.

#### Greens Assessment

In the off season the centre made a decision that all of the greens in the centre should be assessed as to their suitability as venues for allocation of centre events and hosting representative fixtures. In the past representative events have generally been held at either Paraparaumu Beach or Central Levin, the only two clubs that have two natural greens. Accordingly **Howard Ivory** President of Bowls Wellington Green Keepers Association and greenkeeper at the Wilton Bowling Club in Wellington was invited to carry out the assessments. Ivory holds various qualifications within the Turf industry and is also a member of the National Green Keepers Executive. He has also been the winner of the Bowls Wellington and Bowls New Zealand Greenkeeper of the year award.

Ivory visited our club in late October to carry out the assessments. Our greenkeeper **Arne Jansson** was present at the time and felt that the assessment process was pretty cursory. Ivory delivered a few bowls on each green, inspected the ditches and surrounds and made his assessment. There was no unbiased bowl or ramp for use in judging green speed and a reliance on feedback from Arne. He also looked at weed content, bare areas, evenness of cover, the speed of the green plus the specifications of the ditches. No survey of green levels was carried out.

The results of the assessment are set out below:

#### **Dales Green**

1 x Dales Needle Punched Polypropylene Artificial green 36.5m x 36.5m green speed 18/19sec. In good condition overall. Ditches conform.

Not recommended for Centre play due to excessive speed.

### Cotula green

A natural Dioica weed green 36.5m x 35m. Green speed 15 sec. Ditches conform. Green has dense full cover free from weeds. Green speed rain affected.

### Suitable for Centre play.

While our club is generally happy with the report on the cotula green the decision that the Dales green is 'not recommended for Centre play' is rather alarming. The speed of the green varies considerably with overhead conditions being faster on cold days, but the speed is generally in the range of 15 - 17 seconds. The Centre has been happy to use it if rain washes out play on natural greens (as recently as on Saturday 13 November when rain made the Central Levin greens unplayable late in the day in the Men's Open Pairs).

If our Dales green is too fast we wonder how the greens at Waikanae will measure up?

The centre has already indicated that these assessments will have no bearing on the venues for this season's events but the situation is quite fluid as the greens of Waitarere Beach, Central Levin No 2 and Paekakariki have been declared unfit for centre play already this season. If our Dales green and the Waikanae greens are deemed to be too fast then there are very few greens suitable for centre or rep play.

Our Dales carpet green is exactly the same needle-punched polypropylene product as that of Waikanae and of Ivory's home club Wilton B C, and they were all laid within a few months of each other by the same contractor. All have the same base materials and the only real difference is in the thickness of the underlay below the carpet. It is the difference in the type of underlay which means the Waikanae greens are faster than ours.
